### RULES

1. Only allowed to run in one (1) state show per year.
2. Must be NBHA member in good standing whose competition district is in KY. Must have competed in at least 3 district shows prior to September 16, 2017. Cards must be shown the day of the show. ***No membership payments will be taken at the show.***
3. Youth age as of January 1, 2017 is 18 years and under.
4. All entries must be received by September 1, 2017. **Late Fee \$20 per horse.**
5. Late entries taken at the show until 11AM on Saturday, September 16 with a \$20 late fee per horse. ***Office will close at 11AM***
6. Stalls are \$50 each and RV hookups are \$50 each (Price includes Friday & Saturday nights only.) Additional nights available at \$25 each per night.
7. Processing fee \$20 per person.
8. NBHA attire: western, collared, long sleeve shirt, western hat, and boots required.
9. No refunds. No rider substitutions. Horse substitutions are allowed.
10. Returned check fee \$35.
